In accordance with AS 16.05.841, approval to mine is hereby given subject to the following stipulation:

- 1. Construction or maintenance of dams, diversions, fills, deflectors, and any other structure that may impede the efficient passage of fish is prohibited.**

This permit constitutes approval pursuant to AS 16.05.841. The above named person(s) are authorized to operate the described suction dredge within the described stream locations. To be valid, it must be available for inspection while you are mining. This permit is not transferable and does not relieve you from complying with State Water Quality Standards specified by the Department of Environmental Conservation (18 AAC 70.005-990).

Please be advised that this determination applies only to activities regulated by ADF&G, Division of Habitat. *This determination does not relieve you of the responsibility for securing other state, federal or local permits nor does it authorize trespass on mineral claims or private property.* The ADF&G advises the permittee to contact the appropriate landowner or land management agency prior to conducting activities authorized by this permit.

This permit provides reasonable notice from the commissioner that failure to meet its terms and conditions constitutes violation of AS 16.05.861; no separate notice under AS 16.05.861 is required before citation for violation of AS 16.05.841 can occur.

Off-road vehicle access to the mining area that involves ford crossings of anadromous fish streams are NOT authorized by this recreational mining permit. An individual fish habitat permit may be required for these ford crossings. Please contact the Soldotna Division of Habitat office at (907) 714-2475 with any questions.
